Underwriting	All groups must be underwritten to become a member of the Chamber Health Plan. Group size must have from two to fifty eligible families on the plan.
Coverage	Coverage will be issued only on the first of each month after approval from the NHP home office underwriter.
Pre-Existing Clause	No pre-existing clause applies when approved. Everyone who applies and is accepted is covered for all plan benefits from that point forward.
Plan Choice	<p>The following plan choices are available:</p> <ul style="list-style-type: none"> – HMO 1-8 – POS 1-6 – CDHMO / CDPOS 1-3 – HMO / POS Co-Choice Plans – HMO Co-Pay Plans – HMO / POS HSA-Qualified Plans <p>Groups with two or more enrolled employees may dual choice NHP benefit plans provided that each plan offered has a minimum of one enrolled employee.</p>
Plan Flexibility	Groups may choose a waiting period and hourly requirement for its employees to participate in the plan.
Renewal	All groups will renew on their effective date.
